Search Engines/Databases for Systematic Reviews

- [Campbell](#)- an international research network that produces systematic reviews of the effects of social interventions.
- [Compendium of Clinical Practice Guidelines and Systematic Reviews](#)- ASHA's National Center for Evidence-Based Practice in Communication Disorders offers this compendium of clinical practice guidelines from around the world related to audiology and/or speech-language pathology.
- [Cochrane Database of Systematic Reviews](#)- a full-text database containing systematic reviews and protocols of the effects of health care interventions; mainly randomized controlled trials.
- [CRD](#)(Center for Reviews and Dissemination)- provides practical guidance for undertaking evidence synthesis.
- [Database of Abstracts of Reviews of Effects \(DARE\)](#)- structured abstracts of good quality systematic reviews from around the world.
- [PubMed Systematic Reviews](#) (PubMed Clinical Queries: Systematic Reviews)- combines your search term(s) with citations identified as systematic reviews, meta-analyses, reviews of clinical trials, evidence-based medicine, consensus development conferences, and guidelines.

Search Engines/Databases

- [AccessMedicine](#)- clinical reference library includes guidelines, images, drug information, and patient handouts.
- [ACP Journal Club](#)- value-added abstracts to research and systematic review journal articles selected according to explicit criteria from over 100 major peer-reviewed medical journals.
- *[AHRQ Evidence-Based Practice](#) - evidence reports and technical reviews from the Agency for Healthcare Research and Quality.
- [AskERIC](#)- the world's largest source of education information, from the Department of Education.
- *[ASHA journals](#)
- [Bandolier](#)- short evaluations of individual articles dealing with evidence-based clinical practice.
- [BioMedNet](#)- allows you to access a wide range of services for research professionals.
- [CINAHL \(Cumulative Index to Nursing and Allied Health Literature\)](#)- a bibliographic database which covers nursing and allied health literature including speech-language pathology and audiology.
- [CHID online](#)- the bibliographic Combined Health Information Database produced by health-related agencies of the federal government. Contains prepared searches from CHID on [Aphasia](#), [Stuttering](#), [Traumatic Brain Injury](#).
- *[Clinical Evidence](#) - updated compendium of evidence on the effects of clinical interventions. Summarizes the best available evidence and the current state of knowledge based on thorough searches. Categorizes interventions as beneficial, likely beneficial, no known benefit, or harmful. Covers more than 570 conditions.
- *[Clin-eguide : Clinical Decision Support](#) - disease management, drug therapy, laboratory results, in a single resource. Provides a course of action with options.
- [Community of Science](#)- universities, corporations, societies, private institutions, government agencies, and individual researchers all use these services to find funding,

promote their work, identify experts, manage resources, and collaborate with colleagues.

- [Conference Papers](#)- provides citations to papers and poster sessions presented at major scientific meetings around the world.
- [CRISP \(Computer Retrieval of Information on Scientific Projects\)](#)- a searchable database of federally funded biomedical research projects conducted at universities, hospitals, and other research institutions.
- [Dissertation Abstracts Online](#)- provides subject, title, and author information to dissertations accepted at an accredited institution as well as selected masters theses.
- *[DynaMed](#) - provides the evidence to help clinicians make patient care decisions.
- *[EBP-Briefs](#)- seeks to answer biggest questions SLPs face during daily activities
- [eLibrary](#)- over 13 million documents from thousands of newspapers, journals, books, and encyclopedias.
- [EMBASE](#)- a bibliographic database which covers drug research including side effects and drug interactions.
- [Essential Evidence Plus](#) - includes InfoPOEMs (summaries on recent research from a defined set of journals that address questions clinicians face using measures of symptoms, morbidity, quality of life, and mortality outcomes), EBM Guidelines, and e-Essential Evidence.
- [Free Medical Journals Site](#)- over 800 medical journals linked to this site.
- [Google Scholar](#)- search for scholarly literature, including peer-reviewed papers, theses, books, preprints, abstracts, and technical reports from broad areas of research.
- [Higher Education Abstracts](#)- a quarterly compilation of abstracts of journal articles, conference papers, research reports, and books published by Claremont Graduate University.
- [Ingenta](#)- offers the article summaries of over 25,000 publications and the full-text of over 5,400 publications from 160 publishers.
- [KnowledgeFinder Medline](#)- a service where the results are presented as a list and papers assumed most relevant are listed first.
- [OCLC FirstSearch](#)- a library subscription service that provides users online access to more than 70 databases, including OCLC WorldCat, OCLC FirstSearch Electronic Collections Online, OCLC NetFirst, OCLC ArticleFirst, OCLC PAIS International, OCLC PapersFirst, OCLC ProceedingsFirst, and OCLC Union Lists of Periodicals.
- *[OVID](#)- provides access to a variety of resources including bibliographic databases (such as MEDLINE, EMBASE and CINAHL). Offers more than 300 full text journals, other clinical information products such as Evidence Based Medicine Reviews (EBMR), and some textbooks. EBMR provides content from the Cochrane Database of Systematic Reviews and from ACP Journal Club.
- [Northern Light Special Collection](#)- an online library with over 7000 full-text journals, books, magazines, newswires, and reference sources, and includes over 25 million full-text documents.
- [ProQuest Digital Dissertations](#)- allows free access to the most current two years of citations and abstracts in the Dissertation Abstracts database.
- *[PubMed](#)- an internet interface for MEDLINE (the National Library of Medicine's bibliographic database of over 11 million references and abstracts of journal articles in life sciences).
- [REHABDATA](#)- includes research reports, books, journal articles, audiovisual materials, and organizations from the National Rehabilitation Information Center.

- [SUMSearch](#) – simultaneously searches a few free-access sources such as PubMed, NGC, Merck Index, DARE, etc. Results grouped by reviews, practice guidelines, systematic reviews, and research-based articles.
- [The Dome](#)- a information service for speech-language pathologists, audiologists, and students in the field of Communication Sciences and Disorders. Quickly identifies and connects you to books, journal articles, dissertations, authors, grants, institutions, and web sites.
- *[TRIP Database](#) (Turning Research Into Practice)- database performs a simple search of more than 75 databases, including CDSR Abstracts, NGC, Bandolier, Evidence-Based Medicine, DARE, POEMs, etc. for access to evidence-based material as well as articles from peer-reviewed journals.
- [UpToDate](#) - the most current, extensive electronic textbook for medicine. Recommendations are based on the available evidence and the author's clinical experience. Continuously updated.
